



# Estate Administration or 'Probate'

## What is estate administration?

**Estate administration is the process of dealing with a person's legal, financial and personal tax affairs after they have died. The process is sometimes referred to as Probate or Confirmation in Scotland.**

All estates need to be administered to some extent. This normally means dealing with all of their assets (such as personal property and personal possessions) and liabilities (such as outstanding debts) before transferring what's left to the beneficiaries.

## What's involved in the process?

If you are named as an Executor in a Will, or the next of kin if there is no Will, you may need to think about the points below. The list is not exhaustive:

- Gathering all information
- Contacting all people due to inherit and dealing with their questions
- Applying for the Grant of Probate
- Closing bank accounts and paying debts
- Ensuring the family tree information is correct
- Dealing with shares and investments
- Completing inheritance tax forms
- Completing Income tax forms
- Dealing with capital gains tax
- Dealing with specialist legal work

## Important considerations if you choose to do it yourself

Dealing with the administration of someone's estate can take many months (not weeks), depending on the complexity of their affairs. If you think you can do it yourself, make sure you can cope with the demands on your time. It can be a long a complex legal process and timescales are different for each and every estate.

If you choose to administer the estate yourself you can reduce costs but you must deal with a lot of paperwork and take on a lot of responsibility. You cannot cut any corners and are legally responsible for meeting all legitimate claims (including tax). If you don't act correctly, you could be sued by one or more of the beneficiaries and become personally liable for the errors.
